# EXCISE MOVEMENT AND CONTROL SYSTEM

## PHASE 4.0



Cet aperçu présente uniquement les changements qui concernent les messages EMCS entre les opérateurs économiques et l'application EMCS national.

Les modifications résultent essentiellement à la mise en œuvre du Document Administratif Électronique Simplifié (DAEs ou e-SAD en anglais) dans l'EMCS existant, en utilisant les mêmes types de messages.

Par conséquent, ces mêmes messages seront utilisés pour le document d'accompagnement électronique (DAe) ainsi que pour le Document Administratif Électronique Simplifié (DAEs).

Les principaux changements sont les suivants :

- Un nouvel élément est ajouté pour les deux documents (MaturationPeriodOrAgeOfProducts), respectivement champ "durée de maturation ou de vieillissement selon le règlement (UE) 2019/787 (17t)"
- Les désignations des éléments "poids net" et "poids brut" sont modifiées en "masse nette" et "masse brute"
- Le format des éléments "masse nette" et "masse brute" est modifié en "n..16,6"
- Le code 3 - Duty Paid (régime acquitté) est ajouté comme code point d'expédition (case 9d)
- Les codes suivants sont ajoutés comme code lieu de livraison (case 1a) :
  - 9 - Destination - Certified Consignee (nouvelle destination - destinataire certifié)
  - 10 - Destination - Temporary Certified Consignee (nouvelle disposition - destinataire certifié temporaire)
  - 11 - Destination - Return to the place of dispatch of the Consignor (nouveau, uniquement en cas de changement de destinataire - destination - Retour au lieu d'expédition)
